## HOW TO FIX KNEE JOINTS

All orders and P.V.T. 4. DISCONTINUE all irritating acid liquids such as: ORANGE JUICE , GRAPEFRUIT JUICE and SODA POP (this includes diet drinks). Some people may also have to discontinue TOMATO JUICE and SALSA.

See if you don’t feel better in a short amount of time.

Note: Fresh LEMON JUICE is ok. It does not turn acid in the system.
