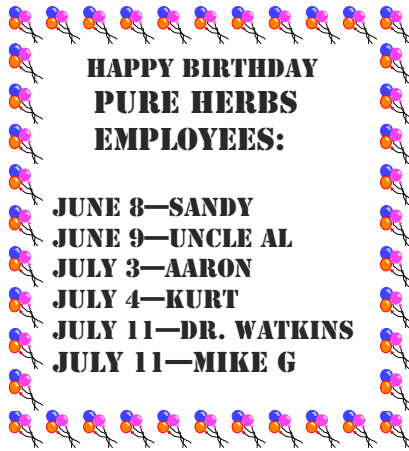

All orders and P.V.T. (Purchase Volume Transfers, which refer to products that were ordered by Distributors that you did not sponsor) **MUST** be called in, faxed in, or received by mail before 5:30 p.m. E.T., on the last business day of the month, which would be Monday-Friday, i.e.: if the 30th is a Saturday, the last business day would then be Friday the 29th.

**RETURN  
POLICY**

**Due to F.D.A. regulations regarding food products, Pure Herbs, Ltd. has a no return policy. The exceptions are breakage and manufacturing defects. To return a product, you must receive prior approval. In the case of shipping errors, returned bottles must be as shipped (free of store pricing labels) and returned in a timely manner (with current lot numbers). All items returned with non-current lot numbers, distributor labeling, or two weeks after receipt, will be charged to your account. This policy is necessary as the returned product must be destroyed due to F.D.A. regulations.**

The intense grass roots response opposing S3002, the misnamed "Dietary Supplement Safety Act of 2010" led to a dialogue between Senator McCain and Senator Hatch. As a result, both Senators McCain and Dorgan have withdrawn support for S3002 and are working with Senators Harkin and Enzi, (Chairman and Ranking Minority Member of the Senate Health, Education, Labor and Pensions Committee) to have some input on the final amendment to the S510 the Food Safety Bill. # Protect Dietary Supplements and DSHEA! Keep FTC Expansion of Authority out of the Senate Wall Street Reform Package

**I strongly oppose including any provision that mirrors Section 4901 of HR 4173, granting the Federal Trade Commission expansive rulemaking powers in Senate Bill 3217, Restoring American Financial Stability Act of 2010 currently on the Senate Floor.** This language is hostile and nongermaine to financial reform. Further when the two bills are brought together in conference committee, **I want Section 4901 stricken from the final bill.**

**The broad expansion deletes pages of current law on the books that were put there to specifically curb abuse of power by the FTC and to keep FTC's powers in check.** The FTC section of the bill has nothing to do with the goals of Wall Street Reform. It has broad consequences that will adversely affect many industries, in particular one **that I care passionately about – the dietary supplement industry.** Given this new authority, the FTC is poised to force the drug approval substantiation model of information and communication exchange onto dietary supplements and other foods. (A model of regulating speech that costs drug companies a BILLION dollars to bring their patented products to market.) It would be a disaster for consumers and manufacturers alike to disallow the use of hundreds of years of traditional use as well as the science currently allowed to be used for substantiation to be thrown out the window.

It is thought that Senator Rockefeller may offer language similar or identical to the House Bill granting the FTC this expanded rulemaking authority. **PLEASE OPPOSE ANY AMENDMENT THAT WOULD GIVE THE FTC MORE POWER. IT IS NOT GERMAINE TO THE WALL STREET AND BANKING REFORM. PLEASE STOP ANY EXPANSION OF FTC AUTHORITY.**

*“Section 4901 removes procedural safeguards that have long prevented FTC from abusively expanding its jurisdiction to regulate all manner of business practices through general rule applicable to entire industries rather than through case by case adjudication applicable to specific parties alleged to have engaged in wrong-doing. The effect is to impose on law abiding parties enormous new regulatory burdens and costs, an undeserved punishment but a particularly onerous one during these tough economic times.” (Attorney Jonathan Emord JD)*
